

Kovitz Investment Group Partners, LLC (“Kovitz”)

Item 1: Introduction Kovitz is registered with the United States Securities and Exchange Commission as an investment adviser. Investment advisory services are different than brokerage services. Fees differ as well, and it is important for you to understand the differences between them.

Free and simple tools are available to research firms and financial professionals at www.investor.gov/CRS, which also provides educational materials about broker-dealers, investment advisers, and investing.

Item 2: What investment services and advice can you provide to me?

Services: We primarily offer investment advisory services to retail (individual) investors. We manage your investments in separate accounts, and invest in a broad range of individual securities, such as equities, bonds, mutual funds, interval funds, exchange-traded funds (ETFs) and external investment managers. We manage your account(s) according to individual needs, and based on a recommended asset allocation or strategy, after considering your objectives, risk tolerance, time horizon, and other factors. We also invest your assets in our affiliated (“proprietary”) mutual fund and ETF, depending on the size of your account, your investment objective, asset allocation, or strategy. We, and an affiliated entity, manage private investment funds and we recommend external private investments, for those who are financially qualified. Similar services as those described above are also offered through other names under which we do business (please refer to ADV Part 1A).

When you hire us as your investment adviser, you give us discretionary authority, which means we don’t need your approval before buying and selling securities in your account(s). However, you can place certain restrictions on us as we manage your account(s) (such as the amount or type of securities), as long as the restrictions are reasonable, and still allow us to manage your account(s) according to our philosophy and preferred investment strategies. We also offer our services on a nondiscretionary basis, where you must approve our recommendation before the trade is placed, which includes investments in our affiliated private investment funds.

We also provide financial planning and counseling services to certain clients to supplement our ongoing advisory services, which can include cash flow analyses and retirement projections, estate planning, and philanthropy management, among other types of reviews. In addition, we provide “family office” services to certain clients, which include comprehensive investment reviews and monitoring, and bookkeeping services and bill pay services, among other things.

Monitoring: As part of our investment advisory services, we monitor holdings and performance on a regular and periodic basis to help ensure they are following our preferred investment strategies or are within acceptable ranges with regard to asset allocation. We also review your accounts in response to other circumstances, such as after material deposits or withdrawals, or other “life events” (e.g., retirement).

Requirements to Open or Maintain an Account

Kovitz does not have a stated investment minimum but generally prefer to require a \$1,000,000 minimum initial relationship for separate accounts. Kovitz has the discretion to accept or decline any client engagement for any reason, in our sole discretion. We also, for certain services, have a stated minimum annual fee.

Item 3: What fees will I pay?**Principal Fees and Costs**

For ongoing advisory services, we charge a fee which we calculate based on a percentage of the assets in your account(s) that we manage, which is usually charged quarterly. The specific fee schedule and methodology of determining your fee is stated in your investment advisory agreement and fee schedule with us. Our fee will generally increase as the assets in your managed account(s) increase, which gives us an incentive to increase the assets in your managed account(s), though the percentage charged may decline as the account assets exceed certain thresholds. If you participate in any of our other services, there are separate fees

associated (typically a fixed fee) that are detailed in your related agreement. Aside from our advisory fees, you will pay various custodial, maintenance, and other fees to your broker or custodian.

Additional Information

You will pay fees and other costs to us and your broker or custodian, whether or not you make or lose money on your investments. Fees, commissions, and other costs will reduce the amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying. Certain investments we select for clients that are managed or sponsored by third parties, such as mutual funds, exchange traded funds and alternative investments, bear fees and expenses for their management and operation. Conversation Starter – “*Help me understand how these fees and costs might affect my investments. If I give you \$10,000 to invest, how much will go to fees and costs, and how much will be invested for me?*”

Standard of Conduct/Conflicts of Interest

What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?

When we act as your investment adviser, we have to act in your best interest and not put our interests ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide to you. For example, we have the discretion to invest your assets in our affiliated mutual funds or ETF, although we don’t charge our standard advisory fees in addition to the funds’ own management fees. We also recommend that clients invest in private placements that are affiliated with us, which are riskier, and the fees are higher than the fees we charge for separate account management. The financial professionals servicing your accounts are compensated for providing this servicing. The factors primarily driving the compensation for each financial professional include the amount of client assets serviced by the financial professional and the revenue the firm and/or our affiliates generate from the professional’s services or recommendations. This presents a conflict and incentive for the financial professional to encourage you to increase the assets in your account or recommend certain products or services offered by our affiliates.

Conversation Starter – “*How might your conflicts of interest affect me, and how will you address them?*”

How do your financial professionals make money? Our client relationship managers are compensated, in part or in whole, with a percentage of the advisory fee that you pay to our firm, which include investments in affiliated and unaffiliated private funds, hedge funds, real estate funds, mutual funds and private equity funds. This creates an incentive for our employees to try to increase client assets in their separate accounts, or assets in our affiliated private placements. Additionally, some employees receive compensation from referrals to affiliated insurance agencies. Compensation is paid only when there is a need for the client and a policy is placed. We and our affiliates refer clients to third-party service providers and are eligible to receive additional compensation for those referrals.

Item 4: Do you or your financial professionals have legal or disciplinary history? No for our firm. Yes for our professionals. You can go to Investor.gov/CRS for a free and simple search tool to research our firm and our firm’s financial professionals.

Conversation Starter – “*As a financial professional, do you have any disciplinary history? For what type of conduct?*”

EXHIBIT – SUMMARY OF CHANGES

This Form CRS dated was amended since March 2023:

To add or adjust the following information:

- a. Highlighting that Kovitz and affiliated entities manage private investment funds (Item 2. Services)
- b. Adding, in response to recent organizational transactions, that Kovitz offers investment advisory services on a nondiscretionary basis (Item 2. Services)
- c. That Kovitz offers bill pay services through it's "family office service" (Item 2. Services)
- d. That Kovitz manages different types of investments that are selected for client accounts and that the client bears the fees and expenses related to the management and operation of those investments. (Item 3. What fees will I pay? – Additional Information)
- e. Kovitz, in response to a recent organizational transaction, receives a technology credit from Pershing based on the amount of assets we have with them (Item 3. "When we act as your investment adviser")
- f. Kovitz will be leveraging its affiliate, Telemus Insurance Services, LLC for insurance referrals instead of Kovitz Insurance Services, LLC
- g. Highlighting that Kovitz recommends external private investments for those that qualify (Item 2. Services)
- h. Item 2. Requirements to Open and Maintain an Account: adjusted the language to note that we don't have an investment minimum, but we prefer to have relationship value of over \$1,000,000 to begin an engagement. And that Kovitz has sole discretion to accept or decline a potential client for any reason.
- i. Item 3. Standard of Conduct/Conflicts of Interest: removed reference to Telemus Insurance Services, LLC and noted that we have multiple affiliated insurance agencies.
